6 **FIREARMS AND WEAPONS**

7
8 **Firearms**

9
10 For the purposes of the firearms section of this policy, the term “firearm” means (A) any weapon
11 (including a starter gun) which will or is designed to or may readily be converted to expel a
12 projectile by the action of an explosive; (B) the frame or receiver of any such weapon; (C) any
13 firearm muffler or firearm silencer; or (D) any destructive device pursuant to 18 U.S.C. 921 (4).
14 Such term does not include an antique firearm pursuant to 18 U.S.C. 921 (16).

15
16 It is the policy of the Yaak School District to comply with the federal Gun Free Schools Act of
17 1994 and state law 20-5-202 (2), MCA, pertaining to students who bring a firearm to, or possess
18 a firearm at, any setting that is under the control and supervision of the school district. In
19 accordance with 20-5-202 (3), MCA, the teacher shall suspend immediately for good cause a
20 student who is determined to have brought a firearm to, or possess a firearm at, any setting that is
21 under the control and supervision of the school district. In accordance with Montana law, a
22 student who is determined to have brought a firearm to, or possess a firearm at, any setting that is
23 under the control and supervision of the school district must be expelled from school for a period
24 of not less than 1 year.

25
26 However, on a case-by-case basis, the Board of Trustees will convene a hearing to review the
27 underlying circumstances and, in the discretion of the Board, the Board may itself modify the
28 requirement for expulsion.

29
30 A decision to change the placement of a student with a disability who has been expelled pursuant
31 to this section must be made in accordance with the Individuals with Disabilities Education Act.

32
33 **Possession of Weapons other than Firearms**

34 The District does not allow weapons on school property. Any student found to have possessed,
35 used or transferred a weapon on school property will be subject to discipline in accordance with
36 the District’s discipline policy. For purposes of this section, “weapon” means any object, device,
37 or instrument designed as a weapon or through its use is capable of threatening or producing
38 bodily harm or which may be used to inflict self-injury, including but not limited to air guns;
39 pellet guns; BB guns; fake (facsimile) weapons; all knives; blades; clubs; metal knuckles; num-
40 chuks (also known as nun chucks); throwing stars; explosives; fireworks; mace or other
41 propellants; stun guns; ammunition; poisons; chains; arrows; and objects that have been modified
42 to serve as a weapon.

43
44 No person shall possess, use, or distribute any object, device, or instrument having the
45 appearance of a weapon, and such objects, devices, or instruments shall be treated as weapons,

3 including but not limited to weapons listed above which are broken or non-functional, look-alike
4 guns; toy guns; and any object that is a facsimile of a real weapon. No person shall use articles
5 designed for other purposes (i.e., lasers or laser pointers, belts, combs, pencils, files, scissors,
6 etc.) to inflict bodily harm and/or intimidate, and such use will be treated as the possession and
7 use of a weapon.

9 The District will refer to law enforcement for immediate prosecution any person who possesses,
10 carries, or stores a weapon **in a school building**, and the District may take disciplinary action as
11 well in the case of a student. In addition the District will refer for possible prosecution a parent
12 or guardian of any minor violating this policy on grounds of allowing a minor to possess, carry,
13 or store a weapon in a school building. (45-8-361 (1) (2))

14
15 For the purposes of this section only, “school building” means all buildings owned or leased by a
16 local school district that are used for instruction or for student activities. (45-8-361 (5a))

17
18 The Board may grant persons and entities advance permission to possess, carry, or store a
19 weapon in a school building. All persons who wish to possess, carry, or store a weapon in a
20 school building must request permission of the Board at a regular meeting. The Board has sole
21 discretion in deciding whether to allow a person to possess, carry, or store a weapon in a school
22 building. (45-8-361 (3b))

23
24 **Weapons used for educational or fundraising purposes may be brought on school grounds by a**
25 **responsible adult with the written permission of the board. Firearms must be unloaded and in a**
26 **condition that renders them incapable of being fired. Ammunition compatible with that firearm**
27 **cannot be on school property concurrently with the firearm. At the conclusion of the display,**
28 **weapons must be immediately removed from school property or stored in a locked, secure area.**

29
30 This policy does not apply to law enforcement officers acting in his or her official capacity.
31 (45-8-361 (3a))

32
33 The trustees shall annually review this policy and update this policy as determined necessary by
34 the trustees based on changing circumstances pertaining to school safety.

35
36 *Note: Section (g) of the NCLB Section 4141 – Gun Free Requirements, carves out a very*
37 *significant exception to the Gun Free Schools Act in that it allows a student to have “a firearm*
38 *that is lawfully stored inside a locked vehicle on school property. . .” Montana law (20-5-202,*
39 *MCA), on the other hand, does not provide for any exception to the expulsion requirement if a*
40 *student has a firearm that is lawfully stored inside a locked vehicle on school property. The only*
41 *reference to federal law in 20-5-202(2), MCA is the federal definition of a firearm. As you well*
42 *know 20-5-202(2), MCA provides that:*

43 *(2) The trustees of a district shall adopt a policy for the expulsion of a student who is*
44 *determined to have brought a firearm, as defined in 18 U.S.C. 921, to school and for referring*
45 *the matter to the appropriate local law enforcement agency. A student who is determined to have*
46 *brought a firearm to school under this subsection must be expelled from school for a period of*
